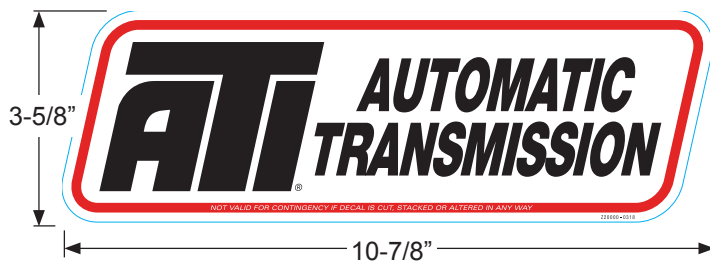

## 2019 ATI Contingency Tech Guide

ATI is posting on two products:

- **ATI Automatic Transmission**
- **ATI Treemaster Converter**



To qualify for these awards, competitors must be using one or more of these posted products and display full size decals on both sides of the vehicle throughout the entire race. Decals must be placed on both sides of the car. Decals on dragsters must be visible from 90°. **Decals cannot be stacked, overlapped, or vary in size, color, shape or be altered in any way.**

ATI Transmissions must have been purchased or freshened up within 3 years from the date of contingency request. ATI Torque Converter must have been purchased or overhauled within 5 years from the date of contingency request. Competitors must also complete ATI's Ad Release & Proof of Purchase form.
